In response to your last request, we have advised you that the Fonds d'aide aux actions collectives (Le Fonds) has withdrawn its objection to the fact that the Applicant is not required to reimburse the balance between the amounts paid by Le Fonds (71 048, \$ 26) and the amount reimbursed in connection with this collective action (\$ 10,000), which is \$ 61,048.26.

When Le Fonds finances a class action, an agreement is signed by Le Fonds, the applicant and his or her lawyer, to reimburse the financial assistance in the file, if the class action is successful by judgment or by In the context of a transaction or agreement, which is the case in this file. If the class action is dismissed by the court or if there is no agreement, the applicant and the lawyer do not have to reimburse Le Fonds.

In this case there was an agreement and the applicant (Ms. Engler, did not mention that it had to repay \$ 71,048.26 to Le Fonds and accepted the \$ 10,000 repayment without the Fund's authorization.

As a result, Le Fonds objected to the Agreement and then withdrew its objection so that Ms. Engler would not be required to repay \$ 61,048.26.

In addition, the amounts you have calculated are inaccurate because you relied on the amounts granted by Le Fonds that are indicated in the decisions we sent to you, not the amounts paid.

However, not all of the amounts awarded (\$ 111,410.00) were paid, only the amount of \$ 71,048.26 was paid, as there was an agreement and the file ends.

Amounts that were not paid (paid to the applicant) are then canceled (\$40,361.74).
